Donating through WIN is the easiest, fastest and most preferred way to make deductions. If you have access to WIN, we encourage you to make your deduction using this method.

# NOT SURE HOW TO MAKE A DONATION THROUGH WIN? JUST FOLLOW THESE SIMPLE STEPS!

- 1. Log-in to your WIN Employee Self Service Page.
- 2. On the top left corner you will see a tab that says 'My Charity', click that.
- 3. You will then see an option that says 'Federated Health, Enter New Deduction', click that.
- 4. You will see another button that says 'Add Deduction', click that.
- 5. Now you can enter in all the details of your donation. (charities to give to, number of pays you'd like to donate for, donation amount, etc.)
- 6. Repeat the above step for each individual charity you want to give to, hitting 'Submit' after each one.
- 7. When you are finished entering in all your deduction details, hit the button that says 'Submit'.
- 8. You're done!












We will send a card to family or friends informing them of your thoughtfulness; the recipient will be told which charity or group of charities was designated to receive the donation (though not the amount of the donation). You can sign up for this option when you make your donation on WIN or by using the donation form. These donations can be made at any time throughout the year.

#### ARE YOU RETIRING FROM THE OPS?

Federated Health Charities runs a biannual retiree mail out campaign. We send out an invitation to donate in the Spring and the Winter. As a retiree, you can make one-time donations through cash, cheque or credit card. If you prefer to make a regular donation you can sign up to make monthly, pre-authorized credit card donations.
