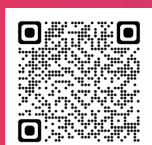

Federated Health Charities was founded by Ontario Public Service (OPS) employees in 1983 to raise funds for health charities in Ontario.

Beginning with fundraising for the Canadian Cancer Society and Heart & Stroke, the annual Federated Health Charities campaign has grown to one of Canada's largest and most successful workplace giving campaigns.

Today we support 21 charities helping people all across Ontario affected by serious illness and life-changing health conditions.

What hasn't changed is the generosity of provincial employees in the OPS, the OPP, and provincial agencies who support our campaign each year in workplaces throughout Ontario.

Since 1983, Ontario's provincial employees have raised nearly \$60 million to improve the health of our communities—a legacy of caring for our friends, neighbours, and fellow Ontarians that provincial employees can be proud of!

THE PATH OF YOUR DOLLAR THROUGH FEDERATED HEALTH CHARITIES



Our 21 charities come together to fund campaign expenses. Federated Health Charities relies on volunteers from the OPS, OPP, and provincial agencies to run our annual campaign, so we can keep our costs low.



Donors give to the campaign. Provincial employees support our campaign by volunteering, donating, participating in campaign events, and purchasing lottery tickets.



Federated Health processes all the funds we receive during the campaign. This includes money raised through payroll donations, one-time donations, campaign events like silent auctions and bake sales, and the sale of lottery tickets.



Federated Health sends the funds we receive to our 21 charities. Federated Health Charities does not keep any of the money we receive. Every dollar given goes directly to our charities to fund the programs and services they provide.

Maximize Your Impact by Donating Through WIN

There are two ways that you can make your payroll donation:

- fill out the attached donation form, or;
- donate online through the WIN Employee Self Service page.

Donating through WIN is the easiest, fastest, and most efficient way to support our charities. You can support any or all of our 21 charities with a click!

When you donate through WIN, you're saving the charities you support money on administration costs, so more of your donation goes to helping people. The amount of your donation will be automatically included on your T4, making claiming your deduction on your taxes a snap.

How to Make a Win Payroll Donation

1. Log in to your WIN Employee Self Service Page.
2. Click the "My Charity" tab in the top left corner of the screen.
3. Click the "Federated Health—Enter New Deduction" option.
4. Select the "Add Deduction" button.
5. Click the magnifying glass for the list of charities and enter the charity or charities that you wish to support in the Federated Health Charity field.
6. Enter the amount to be deducted per paycheque.
7. Enter the number of pays for which the deduction will apply.
8. Select the "Submit" button.

To donate to more than one Federated Health charity, repeat Steps 2-6.

To donate to all charities, select "Federated Health Charities All" in Step 3.

To automatically renew your pledge each year, leave the "Number of Pays" field blank.
